

## Bureaucratic accomplishments

To submit the application:

> **The job giver must submit a flat-rate of 1000€** (to be submitted before the application through the specific module F24);

> Subsequently **there must be an other 6 months of contribution to be contributed in the moment of convocation press the Sportello Unico dell'Immigrazione**. The import of the successive contributions can't be stabilized because it will depend to the typology of the contracts, from the salary level, from the number of hours in duty so it won't be the same for everyone.

## Other useful information

The interpretation of the law and the formulation of the art. 5 of D.lgs. 109/2012, seems to be the one which admits to the regularization not only the foreigners but, at first, **the irregular labor process with a foreign citizen**. On this aspect there still isn't a fair position. It shouldn't be wrong but to try to convert the permissions of stay for example the ones of the seasonal workers or students employed in a full time and undetermined, or other titular workers of permission of stay that doesn't consist the working activity of those who consist of irregular working progresses. It's not incompatible the procedure and above all there is no risk of being private of the title that he/she already possesses.

## IMPORTANT

**Do not turn to persons who wants to give you a regularization application or they depose themselves as job givers or pretend to be paid.** For the Amnesty there is no need to pay anyone and these people are tricksters.

**Do not turn to agencies born recently in your city offering big sums of money to help them** with the documents or they do brokerages between the workers and presume job givers.

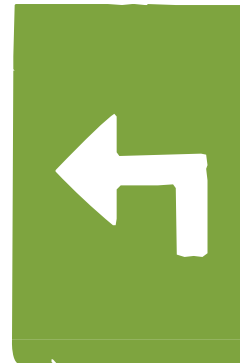

# PER LA SANATORIA 2012

### When and where to present the application:

> **THE APPLICATION OF REGULARIZATION WILL HAVE PRESENTED FROM 15th SEPTEMBER TO 15th OCTOBER 2012.**

> **It's not expected a maximum number of entry**, but all the applications will be examined, that will respond the requested requirements, arrived in the indicated period.

> **The application will be presented through patronage, associations, sportelli but also through single job givers**, through the telephonic procedure of the site of the Home Ministry ([www.nullaostalavoro.interno.it](http://www.nullaostalavoro.interno.it)) which will be accessible after the registration of the user.

### Can present the application:

> **The giver of the job who will be**

- **An Italian citizen;**
- **A public citizen;**
- **An extra UE citizen in possession of the Carta di Soggiorno or rather PdS Ce of long period.**

> **The job giver** has to show a taxable income or a permanent **income source** or the balance of the precedent exercises:

- **for the subordinate workers** non inferior to **30thou euro yearly.**
- **for the workers attached to domestic labour** non inferior to **20thou euro yearly** in case of a nuclear family member composed of a **single preceptor of income or else** non inferior to **27thou euro yearly** in case of a nuclear family composed of **more preceptors of income.**
- **for the foreign workers attached to the assistance no permanent income required.** (In such a situation a declaration of independency must be shown).

> **The working must start before the 09 May 2012** and should still be in process in the moment of the presentation of the application.

> **The working must start in an in determined time or undetermined otherwise full-time** (except in the case of domestic labour).

### It can be scheduled:

> **Who has entered in Italy within the 31 december 2011**

This requirement **must be demonstrated through official documents** (STP, rule of expulsion, medic certificate or nosocomial, visas for touristic reasons sealed in the frontier, seals on the passport). The advice for those who don't have the official documents to attest the presence on the Italian territory before the 31 December 2011 **is to make despite a request because it will make a common problem to many people who in the end will have accept every questions** (to undo the sense of a law of regularization of irregular labor);

> **Who has administrative expulsions related to the norm on immigration** and so has an irregular presence in the Italian State;

### Can't be regularized:

> **Who has expulsions that are consequences of crimes/convictions impedimental to the regularization** [to the sense of the article 13 comma 1 (public order and security of the state) or the article 13, comma 2, letter c)] or if they're not **expulsions motivated to the social risks or to the norm of antiterrorism;**

> **Who results marked (Schengen marked)**, even in base of agreements or international convictions vigor for Italy, **in the borders of the non-admission in the territory of the State**

### THE PROGRESS OF WORK

**The progress of work should start before the 9th may 2012.**

> May be regularized the **reports of labor subordinated in a determined or undetermined period** with a schedule of a **full time.**

> **The progress of domestic labor** in a determined or undetermined time with a schedule of work **in a partial time non inferior to 20 hours weekly.** The payment should be correspondent to that anticipated from the Contratto Colettivo Nazionale of the category of reference and though non inferior to the minimum import expected for the social assignment **(5.577 euro yearly, 429 euro monthly).**
